- Haulers within Springfield are taking very different approaches to recycling and some of the information that Kim gathered in her report (regarding what is being recycled) conflicts with some of the information recently presented by the county (specifically in the context of recyclable plastics)
  - i. The county noted that only 1,2 & 5 are being recycled, however, at least one hauler is accepting numbers 1-7, while others do not clarify at all

- b. Melissa has the Hotspot QR code ready (as well as some additional content ideas for the kiosk) but she is still waiting on BirdTown's approval to include the BirdTown logo
- c. Melissa let the EAC know that the PA Game Commission is currently offering a program (to interested property owners with 25 acres or more) which would provide for the installation of purple martin houses to increase biodiversity
- d. Melissa also shared information with the EAC regarding a grant from PA American Water, which is intended to promote water conservation as well as improve, restore and protect watershed and/or groundwater supplies
